This reform has benefited some industries such as auto parts imports. We currently import thousands kinds of components, and thanks to the policy reforms, we can get these components from all over the world at the first time.



Reform Solves Practical Problems Reform Improve Business Environment



In recent years, cross-border trading has been grown increasingly concerned by governments and corporations. At the end of March 2018, Shanghai government held a press conference, and the deputy secretary-general, director of municipal development and reform commission, Chun-lei Ma introduced the situation of Shanghai optimize business environment specific plan. Also the indicators have been set up for cross-border trade: parallelly open port operations, implement customs declaration and logistics operation synchronously, promote import container from arrival to departure from port area to be reduced by one third; reduce the document time which the export original certificate could be approved in 4 hours by applying self online, and the mechanical and electrical products could get the import license in one day by local commerce authorities. At the same time, the port operation and treatment phase charges will also be publish to public, including categories, items and levels to clean up and regulate unreasonable charging behavior the enterprise reflects.





As the leading enterprise in the industry, Xinhai meeting with China customs brokers, Shanghai customs and other departments to communicate and report the suggestions on optimizing the business environment. Xinhai has been honored to become the world bank's business environment researched object in 2018 by the recommendation of our country's customs and ports department. Understanding of Order No.238 of the General Administration of China Customs (Understanding of some revision by General Administration of China Customs)

Background and purpose of the revision

Implementation subject revision

Business process revision

- •The first session of the 13th National People's Congress deliberated and approved the institutional reform plan of the state Council, which made it clear that " the duties and teams of entry-exit inspection and quarantine administration of the state general administration of quality supervision, inspection and quarantine shall be assigned to the general administration of customs".
- •At the same time, it required that " the implementation of the institutional reform plan needs formulate or modify laws and regulations, and relevant procedures should be started in time".

In the relevant rules and regulations, the " state general administration of quality supervision, inspection and quarantine", " state entry-exit inspection and quarantine bureau" and " state inspection and quarantine bureau" are adjusted to " general administration of customs", the " inspection and quarantine institutions" are adjusted to " customs", the " directly affiliated inspection and quarantine bureau" is adjusted to " directly affiliated customs", and the " branches" are adjusted to " affiliated customs".


•Only " customs" shall be reserved for the provisions of " customs" and " inspection and quarantine institutions" which appear in parallel in the rules and regulations.

- •Delete the relevant provisions that the inspection and quarantine department informed the customs in writing or submitted by the customs to the entry-exit inspection and quarantine institutions for inspection and quarantine.
- •Delete the relevant rules and regulations on the issuance of customs clearance documents or certificates by inspection and quarantine institutions.
- •For the customs rules that have set up the registration system of the administrative counterpart, the provisions on repetitive filing of entry-exit inspection and quarantine related rules shall be deleted.



Operational considerations of integration of customs and inspection

- •You can report to the customs once you have 18 digit number instead of having customs clearance form.
- •The full container cargo (and nonport goods) can be declared to the customs before the change of the bill of lading, and the bill of lading can be delivered to the fleet to handle the box lifting formalities after the completion of the change of the bill of lading.
- Whether there is normal customs release information depends on the time limit for the entry of customs clearance documents and the time limit for the import and export enterprises to pay taxes.



- declaration and Merger of enterprise inspection qualification Record the inspection and quarantine inspection personnel and the customs declaration personnel, and merge them into the customs declaration personnel for the record.
- ·Currently, the dangerous goods of the Lingang city, the scattered goods of the Yangshan Tongjing warehouse and Wusong are implementated to one unpacking and inspection. Before making appointment for customs import inspection. the customer shall check whether to conduct inspection and quarantine inspection by presenting the customs declaration form to room 205, phase I of the dangerous warehouse in Lingang city. After that, the inspection plan can be booked.
- •The merger of customs inspection greatly improves the efficiency of customs clearance of enterprises, and it can basically achieve 48 hours customs clearance. The next step will continue to shorten the time limit for customs clearance and expect the further integration after the commodity inspection is

merged into the customs.



At the early of May 23 Airport Customs convene a tax form printing meeting



In January 2018, the general administration of customs and the state taxation bureau issued a document to implement the reform measures for the printing of the pilot tax bills in the customs and customs areas of Shanghai and Nanjing. In May, the airport customs held a further promotion meeting, which will further promote the tax bill printing reform process.

•According to announcement No.10 of 2018 of the state administration of taxation and the general administration of customs (announcement on printing and reforming pilot of the special customs payment book), since June 30, 2018, all documents and tax forms declared in the upper customs area have been printed in format.

•The format tax form can only be printed after the consignee inserted into the enterprise IC card on the platform, and the unit and consumption unit cannot print.

•Currently the format of the tax bill only supports the electronic guarantee and the payment of the electronic payment mode, the payment of the tax bill printing, delayed payment and DDF can not be used to print the format.

From May 28, 2018, the customs of PVG will select several enterprises to carry out pilot work on this work.

- •Implementation of print-type printing required related hardware and software support.
- •1) Web site: http://online.customs.gov.cn "Internet + customs" integrated online business platform module.
- •2) the browser is the Firefox and Google browser.
- •3) color printers are required. (there is an electronic stamp on the format, which needs to be printed with a color printer.)
- •4) print paper for B5 paper.

•The self-printed typographical customs special payment book is as valid as the printed paper customs special payment book. for example, when enterprises encounter obstacles in related deduction to tax authorities, they can show them announcement No.10 of 2018 of the state administration of taxation of the general administration of customs. If related matters still cannot be made, they can put forward directly to the customs, which will coordinate directly with the tax authorities.



On May 23 morning Airport Customs convene a tax form printing meeting Tips: Enterprises can import and export print tax bill on their own, how to avoid risk?

Before carrying out the business, the customs declaration enterprise shall evaluate the credit rating of the import and export enterprises, i.e., the "consignee".

For discredit enterprises or enterprises that need to pay large amounts of taxes in advance, the customs declaration company shall conduct financial examination of the cash payment capacity of the enterprise, and if the enterprise passes the assessment, it may be used as a substitute for funds.

The import and export enterprises would be suggested to be tax collection mode to simplify the complicated payment process and the problem of cash flow.

Enterprises pay taxes to customs through "summary tax" mode, which can effectively reduce the occupation of enterprise funds and further speed up the customs clearance time limit.

For those who need to pay for taxes by customs declaration enterprise, it is recommended to sign a standard contract.

Customs declaration enterprises need to implement certain tax preservation measures for their legitimate rights and interests. In order to help import and export enterprises to quickly clear customs clearance without delay caused by the payment of tax, we can negotiate with import and export enterprises to sign a standard contract to clarify the responsibilities of both parties.

In recent years, according to the central government's overall deepening reform and deployment, the customs has established a series of customs clearance process optimization with trade facilitation as the core, which has achieved fruitful results. For example, the paperless examination reform and the electronic declaration power of attorney are really centered on " improving efficiency, reducing cost, intelligence and convenience", which brings benefit to the customs clearance of import and export enterprises.

On may 17th, Zhou Xin, general manager of Shanghai Xinhai Customs Brokerage Co., Ltd., was invited to attend the enterprise symposium "Shanghai customs takes various measures and fully supports Shanghai to improve cross-border trade facilitation", and was interviewed by Shanghai television, oriental satellite TV, SMG oriental broadcasting center, Jiefang daily and EastDay.com, and talked about his personal experience as a professional customs declaration enterprise in the tide of deepening customs reform.

Currently, Xinhai is establishing a centralized and single data model to help enterprises cope with the reform of national customs clearance integration. Centralized single center mode will break the limitation of reporting areas and realize centralized management of single data also which will achieve the unity of reporting.

General manager Zhou felt deeply about the optimization of customs clearance process: "paperless inspection brings" efficiency improvement and cost reduction "to enterprises. Before the reform, customs declaration enterprises need to arrange at least five inspectors to complete the inspection work, and after the reform, customs declaration enterprises will reduce the inspectors to 2-3 persons to complete all the inspection work. Electronic customs declaration form also brings intelligent convenience to enterprises, solves the problem of sending security of enterprise documents, and has a complicated process of applying for the official seal step by step.
