








Summary of New Customs Regulations Implemented in February





Announcement of the General Administration of Market Supervision and Administration of the General Administration of Customs No. 14 of 2019

When applying for registration in industrial and commercial registration, the applicant may apply for the Registration Certificate of Customs Declaration Unit at the same time. Enterprises can inquire about the record registration results of consignors and consignors of import and export goods through the "Single Window" standard version of Chinese international trade or the "Internet +Customs". The Customs will no longer issue the Registration Certificate of Customs Declaration Unit. If the consignee or consignor of import and export goods needs to obtain written registration information, he can print the registration receipt online through the "Single Window" and affix the customs seal to the local customs.

Customs strictly checks wooden packages of imported and exported goods. Those without IPPC marks are not allowed to enter or leave the country.

Inbound and outbound goods shall be packed in wood and shall be treated in accordance with the specified quarantine treatment method and marked with IPPC When examining inbound and outbound goods, all customs shall conduct random checks on wooden packages used for the goods. Those do not conform to the regulations are not allowed to enter or leave the country. Legal basis: Article 5 of the Administrative Measures for Quarantine Treatment of Wooden Packaging of Imported Goods; Articles 13 and 14 of the Administrative Measures for Quarantine Treatment of Wooden Packaging of Outbound Goods



Announcement of the General Administration of Customs No. 31 of 2019

Starting from February 17, 2019, antidumping duties will be imposed on imported white meat chicken products originating in Brazil The consignee of imported goods shall, when declaring the chicken wings (wings, the same below) in the product scope of the above anti-dumping measures, subdivide them into whole wings, wing roots, middle wings, two wings and wing tips, and determine the classification (declaration shall be made according to the split tax number) No anti-dumping duty shall be imposed on products under investigation that have signed price commitments and are exported to China at a price not lower than the promised price.




Summary of New Customs Regulations Implemented in February





Announcement No. 18 of 2019

- •On the basis of announcement No. 60 of 2018, amendments were made and some new requirements for filling in standardized declaration categories were added.
- •The concept of "duty-free goods" is introduced, and the import and export declaration of "duty-free goods" is described in a normative way. The implemented " laws and regulations" are incorporated into this declaration guide.
- Correcting the rigor of some words and descriptions
- •The commodity code is still 10 digits, but in addition to the 10 digit commodity code, the declaration form must also selectively declare "inspection and quarantine name" according to different products.





Notice on Adjusting the Nature of Exemption and Other Related Matters of " State Grant Relief"

- •Part of the exemption was added to replace the original "state approved exemption". 701 (part of imported feed), 702 (Chinese funded "flag of convenience" ships), 703 (aircraft imported by airlines), 706 (aircraft imported by leasing enterprises) and 708 (replacement of agricultural products) were added.
- •When declaring the above goods with tax reduction or exemption to the customs, the declaration shall be made in accordance with the clear nature of the tax reduction or exemption.

Category	Announcement number	Brief description of relevant contents
	Announcement of the General Administration of Customs No. 30 of 2019	Registered Philippine factories are allowed to import fruits that have undergone quick freezing treatment at - 20 $^{\circ}$ C or below after removing the inedible peel and are transported in cold storage at - 18 $^{\circ}$ C or below. The varieties of frozen fruits allowed to be imported are: frozen banana (Musa sapientum), frozen pineapple (Ananas comosus) and frozen mango (Mangifera indica).
	Announcement No. 25 of 2019 of the Agricultural and Rural Department of the General Administration of Customs	To prevent the introduction of Mongolian African swine fever into China. First, the recent outbreak of African swine fever in Bulgan, Mongolia and other 4 provinces. Secondly, the two countries have not signed an agreement on access to swine, wild boars and their products with Mongolia. The result is a ban on importing swine, wild boars and their products directly or indirectly from Mongolia.
Animal and plant products access	Announcement No. 24 of 2019 of the Agricultural and Rural Department of the General Administration of Customs	Lifting ban on foot-and-mouth disease in parts of Mongolia. The ban on foot-and-mouth disease in parts of Zamenud City, Donggobi Province, Mongolia was lifted.
	Announcement of the General Administration of Customs No. 23 of 2019	Lifting the risk warning of nodular dermatosis in Kazakhstan. Kazakhstan has lifted restrictions on exports to China due to bovine nodular dermatosis. Specifically, if the import inspection and quarantine is to be handled, the customs will have to issue relevant regulations.
	Animal and Plant Inspection Warning [2019] No.2	The warning notice of outbreak of Koi herpes virus disease in Iraq relates to live carp cultured in fresh water (HS codes 03011993390, 03011993310, 0301193100, 03011939000, 030119010). It refers to countries in the region: Iraq and neighboring countries. The treatment method is to carry out quarantine inspection on imported or transit Cyprinidae aquatic animals for batches of Koi herpes virus disease. If unqualified, immediate return or destruction measures are taken.

Health quarantine	Announcement of the General Administration of Customs No. 21 of 2019	2018 "International Health Regulations (2005)" Port Public Health Core Competencies meet the standards. Customs has released a list of 273 ports in the country that have reached the hygiene standards.
	Announcement of the General Administration of Customs No. 19 of 2019	Prevent yellow fever epidemic from being introduced into China. Nigeria has been listed as a yellow fever epidemic area since January 22, 2019. Transportation, containers, goods, luggage, mail and express mail from Nigeria must be subject to health quarantine. The announcement is valid for 3 months.
Certification and accreditation regulatory	Announcement of the General Administration of Market Supervision on Issuing the "Rules for Energy Efficiency Testing and Evaluation of Heat Exchangers" [No.2 of 2019]	Define the energy efficiency test and evaluation methods and energy efficiency indexes of heat exchangers.
Administrative approval	Announcement of the General Administration of Market Supervision on Matters Related to Administrative Licensing of Special Equipment [No.3 of 2019]	The existing special equipment production license items, special equipment operators and inspection personnel qualification items have been streamlined and integrated. Reduce the systematic transaction costs of enterprises and strengthen the supervision of special equipment. The above catalogue and projects will be implemented from June 1, 2019.
National standard category	TB/TCFDIA004-2018 " High Quality Down Clothing" Standard will be implemented on January 1, 2019	This standard is especially aimed at high-quality eiderdown. The reason why it is so high is that it improves the assessment standards in terms of filling materials, appearance quality, etc. In the "High Quality Down Garment" standard, the content of down fibers is used instead of the content of down fibers, thus eliminating the dishonest behavior of adding down fibers into down fibers for inferior quality. The standard also stipulates that the nominal value of lint content shall not be less than 85%. "Increasing this threshold is based on the quality level of most down garments in the current market, because some down garments with a nominal down content of 90% have only 81% actual down content."

Category	Announcement number	Brief description of relevant contents
Food safety	Announcement of the General Administration of Customs No. 29 of 2019	Food imported into the comprehensive bonded zone that needs to enter the territory can be assessed for conformity in the comprehensive bonded zone and released in batches. Where laboratory tests are required, they can be released after sampling on the basis of satisfying the conditions. If the laboratory tests find that the safety and health items are unqualified, the importer shall take active recall measures in accordance with the provisions of the "Food Safety Law" and shall bear corresponding legal responsibilities.
	Notice of the General Office of the General Administration of Market Supervision on Public Solicitation of Opinions of the General Administration of Market Supervision on Relevant Provisions of Health Food Label Management (Draft for Comments)	The annex to the notice has the requirements of the relevant regulations on the label management of health food, which clearly states that the label content of health food shall be consistent with the corresponding content stated in the health food registration certificate or filing certificate. And the special reminder should be printed in bold type, including the following contents: health food does not have disease prevention and treatment functions. This product cannot replace drugs. The height of the font is also specified.
	Notice of the General Administration of Market Supervision on Issuing the 2019 Food Safety Supervision and Sampling Plan	The "double random" sampling inspection is mainly carried out on large wholesale markets nationwide and some key food production enterprises. Including infant formula food, dairy products, meat products, beverages, alcohol, edible agricultural products and other 31 categories. For food processing products, edible oil, dairy products, beverages, wine, biscuits, fried foods and nut products, a certain number of online shopping foods and imported foods will be sampled. In combination with daily supervision, special rectification and public opinion monitoring, special spot checks will be conducted on the problems that are more prominent. Schedule: Sampling inspection shall be carried out monthly for all products of domestic and imported infant formula milk powder manufacturers registered with the formula and on sale, and sampling inspection shall be carried out quarterly for edible agricultural products, online food and imported food.

- •Shanghai Runjia International Agricultural Products Logistics Trading Center is located at No. 188 Xingkun Road, Changxing Island, Shanghai. It is 20 minutes from Waigaoqiao Free Trade Zone, 25 minutes from Pudong Airport, 30 minutes from Shanghai downtown, and 50 minutes from Shanghai Yangshan Port. The G40 highway runs through the whole line, connecting Shanghai, Jiangsu, Anhui, Shandong and other peripheral trade first-tier cities without barrier.
