
ATA Applicable Business Category Expansion

- Announcement No.212 of the General Administration of Customs ("Administrative Measures of the Customs of the People's Republic of China for Temporary Entry and Exit of Goods")
- •The goods temporarily imported using the temporary goods import document (hereinafter referred to as ATA carnet) are limited to the goods specified in the international conventions on temporary goods import to which China is a party.
- Until 2019, ATA carnet will only be used for "goods displayed or used in exhibitions, fairs, conferences and similar activities".



Effective January 9, 2019.



•Announcement No.193 of 2019 of the General Administration of Customs (Announcement on Temporary Entry of ATA Carnets for Sports Goods)In order to support China's hosting of Beijing 2022 Winter Olympics and Winter Paralympics and other sports activities, according to the provisions of international conventions on temporary import of goods, the customs will accept temporary import ATA carnets for "sporting goods" from January 1, 2020. The ATA carnet can be used to go through the customs formalities for temporary entry for the necessary sporting goods for sports competitions, performances and trainings.



- •The above can be referred to the Istanbul Convention
- Our country has expanded its acceptance of the Convention on Temporary Admission (Istanbul Convention) with Appendix B.2 on Professional Equipment and Appendix B.3 on Containers, Pallets, Packaging Materials, Samples and Other Imports Related to Commercial Operations.



ATA Applicable Business Category Expansion



Matters 1 needing attention in declaration

Provide ATA carnet marked with the purpose of the above four types of goods (exhibition, sporting goods, professional equipment and commercial samples) to declare to the customs.





Matters 2 needing attention in declaration

In addition to providing ATA carnets, importing enterprises are required to provide other information to prove the use of imported goods, such as national batch documents, detailed descriptions of goods by enterprises, and lists of goods.

Matters 3 needing attention in declaration

ATA carnets handled overseas shall be filed electronically with the China Council for the Promotion of International Trade/China International Chamber of Commerce before being used in China.



Part of Imposition of Tariffs on US Suspended





China suspends levying tariffs on some commodities

For some imported goods originating in the United States that were originally scheduled to be subject to tariff increases starting at 12: 01 on December 15, 10% and 5% tariffs will not be imposed for the time being (Tax Committee Announcement [2019] No.4), and the tariff increases on automobiles and parts originating in the United States will continue to be suspended (Tax Committee Announcement [2019] No.5).

Maintain the scope of levy

Other measures to levy customs duties on the United States continue to be implemented in accordance with regulations, and the elimination of customs duties on goods in the United States continues. (Tax Committee Announcement [2018] No.5, Tax Committee Announcement [2018] No.6, Tax Committee Announcement [2018] No.7, Tax Committee Announcement [2018] No.8, Tax Committee Announcement [2018] No.13, Tax Committee Announcement [2019] No.3,)

Keep attention

- Concerned about China's Exclusion of Tariff-levying Commodities from the United States (Announcement of the Tariff Commission of the State Council on December 19 on the First Batch of Second Exclusion Lists of Tariff-levying Commodities from the United States)
- Pay attention to China's Exclusion of Tariff-levying Commodities from the United States
- Concerned about the phased elimination of tariff increases on Chinese products promised by the United States, and realizing the change of tariff increases from higher to lower.
- Pay attention to the signing of the first phase of Sino-US economic and trade agreement





Maintain the scope of levy

- •The tariff rate on the original US \$250 billion of goods will remain unchanged at 25%
- •Including US \$34 billion (to be implemented from July 6, 2018)
- •US \$16 billion (to be implemented from August 23, 2018)
- •US \$200 billion (to be implemented from September 24, 2018)

Tax reduction and increase list/deferred increase list

- •Regarding the US \$ 300 billion A list of commodities, the US said that it could reduce the tariff rate in the future as the negotiations proceed.
- •For US \$300 billion B list goods, the original 15% tariff rate will not be imposed for the time being.

US Initiated Tariff Increase Exclusion List

•At present, the United States has announced the 17th batch of 200 billion tariff exclusion lists.



Check The Matters Needing Attention For Customs Clearance After The Fourth System Goes Online



Check The Matters Needing Attention For Customs Clearance After The Fourth System Goes Online





Does the receipt of the single window show that "customs declaration port inspection" refers to customs inspection?

Including customs inspection and original CIQ inspection, the specific inspection instructions and inspection contents shall be determined according to the instructions of the four systems.



Does the receipt of the single window show that "destination inspection" includes customs inspection?

"Destination inspection" generally refers to the external package inspection, animal and plant inspection or quality inspection after the goods arrive at the destination. Customs inspection is usually completed at the port.



Will there be receipts for "customs declaration port inspection" and "destination inspection" for one shipment?

Yes, it needs to be inspected twice and dropped twice, but the probability is very low.



How to check if one shipment has been finished inspection at the destination?

You can inquire in the WeChat public number of "Tongguan Bao". If the destination inspection has been completed, the inquiry status is "Destination Inspection Completed". Importing enterprises need to manage the inspection status of goods to avoid missing inspection.

From December 13, 2019, fresh grape (scientific name Vitis vinifera I., English name Table grapes) produced in Argentine grape producing areas will be allowed to be exported to China. the imported products must meet the requirements for quarantine of fresh grape plants in Argentina.
	Announcement No.192 of 2019 of the General Administration of Customs and the Ministry of Agriculture and Rural Areas	Announcement on Preventing Nodular Dermatosis in bos frontalis from Entering China. From December 6, 2019, direct or indirect import of cattle and related products from India is prohibited.
	Announcement No.190 of 20 <mark>19 of the General</mark> Administration of Customs	Announcement on Inspection and Quarantine Requirements for Imported Korean Sweet Pepper. From December 9, 2019, different varieties of sweet pepper (Capsicum annuum var. grossum) planted in Korean greenhouses will be exported to China, and imported products must meet the requirements of Korean sweet pepper inspection and quarantine.
	Announcement No.189 of 2019 of the General Administration of Customs	Announcement on Inspection and Quarantine Requirements for Imported Thai Rice Bran Meal (Cake) and Palm Kernel Meal (Cake). Starting from December 9, 2019, Rice Bran meal (cake) and Palm Kernel meal (cake) produced by oil extraction technology from Rice Bran and Palm Kernel in Thailand will be exported to China. Imported products must meet the inspection and quarantine requirements of Thailand Rice Bran meal (cake) and Palm Kernel meal (cake).

From December 9, 2019, Rapeseed meal (cake) produced from rapeseed planted in Ukraine after separation of oil by squeezing, leaching and other processes will be exported to China. Imported products must meet the inspection and quarantine requirements for Rapeseed meal (cake) in Ukraine.
	Announcement No.187 of 2019 of the General Administration of Customs	Announcement on Quarantine Requirements for Imported Mexican Banana Plants. From December 9, 2019, bananas (scientific name Musa spp., English name Banana) produced in Mexico's banana producing area are allowed to be imported into China. Imported products must meet the requirements of Mexican banana plant quarantine.
	Announcement No.186 of 2019 of the General Administration of Customs	Announcement on Quarantine Requirements for Imports and Exports of Fruits from China and Uzbekistan Passing through Third Countries. Fruits exported to China by Uzbekistan through third countries refer to fruits produced in Uzbekistan that enter through the three ports of Khorgos, Alashankou and Ilg Shitan.
	Announcement No.185 of 2019 of the General Administration of Customs	Announcement on Quarantine Requirements for Importing Greek Fresh Kiwi Plants. Fresh Kiwi fruit (scientific name Actinidia chinensis, A. deliciosa, English name kiwifruit) produced in the kiwifruit production area of Greece has been exported to China since November 29, 2019. Imports must meet the quarantine requirements of Greek fresh kiwi fruit plants.
	Announcement No.184 of 2019 of the General Administration of Customs	Announcement on Quarantine Requirements for Fresh Edible Avocado Plants Imported from Philippines. HASS Avocado (scientific name Persea americana Mills, English name Avocado) has been exported to China since November 29, 2019. Imports must meet the quarantine requirements of Philippine fresh avocado plants.

Green beans produced and processed in Ethiopia since November 21, 2019 are allowed to be exported to China. Imports must meet the requirements of Ethiopia's mung bean inspection and quarantine.
Animal and plant products access	Announcement No.179 of 2019 of the General Administration of Customs	Announcement on Inspection and Quarantine Requirements for Imported Kazakhstan Forage Wheat Flour. Fine powdery feed raw materials (whole wheat flour, including bran) obtained from processing spring wheat produced in Kazakhstan on November 21, 2019 are allowed to be transported to China. The import of feeding wheat flour must meet the inspection and quarantine requirements of Kazakhstan.
Administrative approval	Announcement No.52 of 2019 of the Ministry of Industry and Information Technology of the People's Republic of China	The import of radio transmission equipment for sale and use in China that is listed in and meets the "Catalogue and Technical Requirements for Micropower Short-range Radio Transmission Equipment" does not require a radio frequency license, a radio station license and a radio transmission equipment model approval, but it shall comply with laws and regulations such as product quality, national standards and the relevant provisions of the national radio management.
