Sino-US Tariff Increase Progress in September





300 billion US dollars to increase tariffs to extend the validity period of exclusion

 On August 28, the Office of the United States Trade Representative announced a list of products with a tariff increase of 300 billion US dollars to extend the expiration date. The exclusion period of some products is extended from September 1, 2020 to December 31, 2020.

Products involved in excluding extended period

 There are 214 items in the original US list of 300 billion tariffexcluded products, and 87 items have been postponed this time, so there is no need to levy additional tariffs during the extension period.

Products without extended validity period


 For products removed from the exclusion list from September 1, 2020, an additional tariff of 7.5% will be resumed.

Announcement of the Tax Commission [2019] No.6

- In the announcement, the list of the first batch of goods with tariffs imposed on the United States was announced for the first time. From September 17, 2019 to September 16, 2020, the tariffs imposed by the 301 measures against the United States will not be added. After the expiration, the tariff increase will still be resumed.

Announcement of the Tax Commission [2019] No.8

• The Customs Tariff Commission of the State Council announced the first exclusion extension list for the US tariff products, and the Announcement of the Customs Tariff Commission of the State Council on the First Exclusion List of the First Batch of Tariff Products Imposed on the US (Tax Commission Announcement [2019] No.6). The exclusion period is extended by one year. From September 17, 2020 to September 16, 2021, the tariffs imposed by the anti-US 301 measures will continue to be exempted.

New Paperless Platform for Customs Inspection







Applicable Business

- Import business needs to supplement the documents uploaded at the request of the customs
- Declaration on suitability of outbound containers
- · Outbound packaging declaration

Introduction of new paperless platform for customs inspection

• According to the reform arrangement of paperless document declaration business of the General Administration of Customs, since September 11th, the new paperless platform of customs has been launched in the whole country. Paperless accompanying documents declaration for entry inspection and quarantine, paperless accompanying documents declaration for exit inspection and quarantine, paperless accompanying documents declaration for suitable loading of exit container and paperless accompanying documents declaration for exit packaging shall be declared through a single window of international trade. Paperless accompanying documents declared by other channels will not be accepted by the new paperless platform of customs.

New Paperless Platform for Customs Inspection



Uniqueness of input platform

Enterprises in various regions must declare through the "single window" of international trade when applying for paperless documents accompanying entry-exit inspection and quarantine and paperless documents accompanying exit packaging. Customs declaration through other channels will not be accepted.

How to enable the application

It is necessary to bind the registration number of the inspection unit of the enterprise in the "Enterprise Qualification" module of a single window. If it is not bound, the new paperless platform function cannot be used.

How to initiate the cancellation function

 This function has not been developed yet in the new platform. If an enterprise needs to cancel a customs document, it should contact the relevant customs departments of each customs area and handle it offline.

Is it available to upload the attached documents multiple times • Yes. Enterprises can add electronic document declaration and re-enter the same inspection lot number to upload attachment declaration. If the two-step declaration does not return the inspection number, how can the enterprise upload the accompanying documents of inspection and quarantine? • Enterprises can log in to a single window-paperless inspection and quarantine-electronic document declaration-other electronic declaration document

Summary of Inspection and Quarantine Policies



Category	Announcement No.	Comments
	Announcement No.106 of 2020 of the General Administration of Customs	Announcement on quarantine and hygiene requirements for imported French poultry and eggs. From September 14th, 2020, French poultry and eggs will be allowed to be imported. Imported breeding eggs refer to birds and fertilized eggs used for incubating and reproducing young birds, including chickens, ducks and geese. This announcement has made provisions in nine aspects, such as quarantine examination and approval requirements, requirements for animal health status in France, requirements for animal health in farms, hatcheries and source populations, requirements for disease detection and immunization, requirements for quarantine inspection before export, requirements for disinfection, packaging and transportation, requirements for quarantine certificates and requirements for disease detection.
Animal and	Announcement No.105 of the Ministry of Agriculture and Rural Affairs of the General Administration of Customs in 2020	Announcement on preventing Malaysian horse plague from being introduced into China. Since September 11th, 2020, it is forbidden to import equine animals and their related products directly or indirectly from Malaysia, and once found, they will be returned or destroyed.
Plant Products Access	Announcement No.104 of the Ministry of Agriculture and Rural Affairs of the General Administration of Customs in 2020	Announcement on preventing German African swine fever from being introduced into China. Since September 11, 2020, it is forbidden to import pork, wild boars and their products directly or indirectly from Germany, stop issuing the Entry Animal and Plant Quarantine Permit for importing pork, wild boars and their products from Germany, and cancel the Entry Animal and Plant Quarantine Permit that has been issued within the validity period. Pork, wild boars and their products shipped from Germany since the announcement date will be returned or destroyed.
	Announcement No.101 of 2020 of the General Administration of Customs	Announcement on plant quarantine requirements for imported fresh blueberry from Zambia. From September 7, 2020, fresh blueberries produced in Chisamba area of Zambia will be allowed to be imported. Commercial-grade Fresh blueberry, scientific name Vaccinium L., English name Fresh Blueberry. It is required that blueberry orchards, packaging plants, cold storages and treatment facilities exported to China shall be examined and filed at the Plant Quarantine Bureau representing the Ministry of Agriculture of the Republic of Zambia, and shall be jointly approved and registered by the General Administration of Customs of the People's Republic of China and the Ministry of Agriculture of the Republic of Zambia. The packaging, quarantine treatment and quarantine certificate of products exported to China must meet the Quarantine Requirements for Imported Fresh Blueberries from Zambia.

	Warning Circular of Animal and Plant Quarantine Department of General Administration of Customs on Strictly Preventing the Introduction of Malaysian African Marmite	Since September 3rd, 2020, it is forbidden to import equine animals and related products directly or indirectly from Malaysia. Once found, equine animals and their related products will be returned or destroyed. Until September, 2020, Malaysian equine animals and related products have not received quarantine access in China.
Animal and Plant	Warning Circular of Animal and Plant Quarantine Department of General Administration of Customs on Strengthening Quarantine of Imported Australian Barley and Wheat	Since August 31, 2020, all customs offices have suspended the acceptance of barley declaration delivered by CBH GRAIN PTY LTD in Australia after September 1, 2020. Strengthen the verification of imported Australian wheat phytosanitary certificate, review the product name and botanical name on the phytosanitary certificate, carry out laboratory identification when necessary, and confirm that the products that have not obtained quarantine access to China will be returned or destroyed.
Products Access	Announcement No.97 of 20 <mark>20 of the</mark> General Administration of <mark>Customs</mark>	Announcement on quarantine requirements of imported Dominican fresh avocado plants. Since August 26, 2020, fresh avocados (Hass varieties) produced in Dominican avocado producing areas are allowed to be imported under the scientific name Persea americana Mills. Orchards and packaging factories must be registered with the General Administration of Customs of China. The product packaging and phytosanitary certificate shall comply with the relevant provisions of Quarantine Requirements for Imported Dominican Fresh Avocado Plants.
	Announcement No.96 of the M <mark>inistry of</mark> Agriculture and Rural Affairs <mark>of the</mark> General Administration of Cust <mark>oms in</mark> 2020	Announcement on preventing foot-and-mouth disease in Mozambique from being introduced into China. From August 20, 2020, it is forbidden to import cloven-hoofed animals and their related products directly or indirectly from Mozambique (products from cloven-hoofed animals that are unprocessed or processed but may still spread epidemic diseases). Once found, it will be returned or destroyed.
Food Safety	Announcement No.103 of 2020 of the General Administration of Customs	Announcement on implementing emergency preventive measures for overseas production enterprises of imported cold chain food with positive nucleic acid in SARS-CoV-2. Since September 11, 2020, if the Customs has detected SARS-CoV-2 nucleic acid positive for the cold chain food or its packaging exported to China by the same overseas production enterprise for the first time and the second time, the Customs will suspend the import declaration of the enterprise's products for one week. Automatically recover after the expiration; If the same overseas production enterprise has been detected to be positive for SARS-CoV-2 nucleic acid for 3 times or more, the customs shall suspend the import declaration of the enterprise's products for 4 weeks, and automatically resume after the expiration of the period.

License Approval	Announcement of the General Administration of Market Supervision No.39 of 2020	1. Announcement on Implementing the Implementation Opinions of the General Office of the State Council on Supporting Export Products to Domestic Sales will be implemented from September 4, 2020. (1) Accelerate the market access for domestic sales. Before the end of 2020, enterprises are allowed to sell in a self-declared way that meets mandatory national standards. Domestic products shall conform to mandatory national standards. Relevant enterprises can make a statement that the products meet the mandatory national standards through the enterprise standard information public service platform, or in the form of product specifications, factory certificates, product packaging, etc., and the provisions of laws and regulations shall prevail; Open a fast-track for domestic production and sales approval, optimize the approval service for export-to-domestic products managed by the industrial product production license and special equipment production unit license access system, streamline the process and reduce the time limit; To streamline and optimize the compulsory product certification procedures for products transferred to domestic market, the designated institutions of compulsory product certification (CCC certification) should take measures such as opening up green fast track, actively accepting and acknowledging the existing conformity assessment results, expanding online services, shortening the processing time of certification certificates, reasonably reducing and exempting CCC certification fees for products transferred from export to domestic market. (2) Support enterprises to develop products of "same line, same standard and same quality", and expand the scope of application of "three similarities" to general consumer goods and industrial products. That is, products that can be exported and sold domestically are produced on the same production line according to the same standards and quality requirements, helping enterprises to reduce costs and realize the transformation of domestic and foreign sales. 	No.14 [2020] of the Agricultural Measures Letter	The reply from the General Office of the Ministry of Agriculture and Rural Affairs on the applicable law of pesticide components detected in fertilizer products clearly stated that pesticide components contained in fertilizer products should be managed as pesticides. Pesticides produced without pesticide registration certificate shall be treated as fake pesticides.
