Analysis of new CIQ policies in May

Summary of safeguard measures for maintaining foreign trade stability and customs clearance under Covid-19

SIPG

- The preferential relief measures for the usage fee of imported heavy coontainers (unloading ships and entering the port) will be extended further. During the period from 0: 00 on April 22 to 24: 00 on May 31, 2022, if you apply for the plan of picking up imported heavy containers (unloading the ship and entering the port) through the service platform of Shanghai International Port Group (www.sipg.com.cn), eight container terminals under Shanghai International Port Group will give 50% discount to the use fee of imported heavy containers (excluding refrigeration).

- Since April 14th, Shanghai International Port Group has independently chosen to implement the latest version of the national standard (GB16994.3-2021), that is, containers loaded with Class 8 and Class 9 solid dangerous goods can be mixed with common cargo containers when the goods contained have no secondary danger, and the packages are not Class I and Class II and do not belong to dangerous chemicals. After the implementation of this standard, the storage capacity of Class 8 and Class 9 solid dangerous goods containers in Shanghai Port Terminal has been released. At present, dangerous goods containers in Shanghai Port can be unloaded normally.





Customs in Yangtze River Delta ensures the safe and smooth supply chain of industrial chain

- Under the guidance of the General Administration of Customs, a coordination mechanism involving the customs of Shanghai, Nanjing, Hangzhou, Ningbo and Hefei will be established.
- According to the enterprise's application, the customs actively adopts the mode of exempting the consignee or consignor from on-site inspection;
- Strengthen the contact and cooperation among the entry and exit ports, declaration destinations and destination customs to ensure "one declaration, one inspection and one release";
- Five customs offices set up consultation hotlines and special windows at each business site to solve problems encountered by enterprises in the process of customs clearance in a timely manner;
- Give full play to the advantages of railways and waterways, and support enterprises to adopt "water-to-water transfer", "sea-rail combined transport" and "linkage connection and unloading" transfer modes;

During the epidemic control period, according to the entrustment of MSC, adjust the operation method of import exchange. For details, please refer to the Operation Method of Lindomsc Import Exchange during the epidemic control period of Liandong Shipyard. Attached is the Application for Online Electronic Exchange of Bills. To reduce or exempt the related container delay fees incurred by customers in importing . goods at Shanghai Port. Specifically, customers can apply for exemption of the import container delay fees incurred from March 28th to April 30th. ZIM The original bill of lading can be returned to other places, and the electronic bill of lading can be handled in Shanghai. Any branch company such as Ningbo, Qingdao and Nanjing can accept the service from other places. For the dry and frozen goods imported from Shanghai, ONE will exempt the extra container delay fee caused by the epidemic situation in Shanghai. For those who have booked through ONE QUOTE and cannot be shipped out on time due to the epidemic situation, if they are cancelled, they will be exempted from the expenses One Ocean Network Express incurred. For all dry or frozen goods exported from Shanghai, the discharge fee or the bill of lading change fee will be exempted; If the bill of lading is signed or paid by the third place, the bill of lading service fee of the third place will be waived. Reduction and exemption policy of delay payment during epidemic situation at major ports in Shanghai

If the import port of the overdue declaration and customs declaration documents during the epidemic containment period is Shanghai, the initial levy date of "delay payment" will be on or after March 28th (with the closure and control arrangement and resumption date determined and published by the Shanghai municipal government as the node). In principle, the levy date will be postponed according to Article 16 of the Measures for Delay Payment, and no delay payment will be levied.

Application materials: customs declaration number, description of the situation, and the materials that the customs determines need to be provided by the enterprise;

Note: Before applying, the enterprise needs to confirm whether it has paid the delay payment. If it has, it can apply for refund.

Overview of the implementation of the new policy of customs clearance in June

Announcement No.33, 2022 of the General Administration of Customs According to the relevant provisions of the Free Trade Agreement between the Government of the People's Republic of China and the Government of the Republic of Korea and the resolution of the Joint Commission, the restriction of the upper limit of 20 items in the certificate of origin of import and export goods under the agreement is cancelled, and the format of the certificate is implemented in accordance with the annex. This announcement shall come into force on June 12, 2022.

Detailed Rules for the Implementation of Regulations of the People's Republic of China on the Registration and Administration of Market Subjects Article 70 : If a market entity fails to publicize or submit an annual report within the time limit prescribed by laws and administrative regulations, it shall be listed in the list of abnormal business operations by the registration authority, and a fine of less than 10,000 yuan may be imposed.

Before June 30th, when an enterprise submits its annual report in the annual report system of the market supervision department (National Enterprise Credit Information Publicity System), if it is unable to submit the annual report to the customs without the "customs declaration information" module, the enterprise can make a supplementary report through the "single window" of China's international trade.

Overview of the implementation of the new policy of customs clearance in June



Announcement of the State Food and Drug Administration, the State Health Commission and the State Medical Insurance Bureau on the Second Batch of Implementation of the Unique Identification of Medical Devices (114 of 2021)

From June 1, 2022, the medical devices produced shall have the unique identification of medical devices; The second batch of products with unique identification that have been produced before may not have unique identification. The date of production is subject to the label of medical devices.

From June 1, 2022, when applying for the first registration, renewal of registration or change of registration, the registration applicant/registrant shall submit the product identification of its smallest sales unit in the registration management system. Product identification does not belong to the registration review, and the individual change of product identification does not belong to the category of registration change.

- On November 30, 2021, the General Administration of Market Supervision issued the Announcement of the General Administration of Market Supervision on Administrative Licensing of Special Equipment, which mentioned that some catalogues and items were newly formulated, revised and adjusted, and it was implemented on June 1, 2022.
- Among them, the revision and adjustment of the License Catalogue of Special Equipment Production Units is closely related to the declaration of imported special equipment. China's customs has added the content of special equipment attribute declaration in China's international trade "single window" system. The purpose is to implement the reform requirements of "streamline" administration, delegate power, strengthen regulation and improve services" of the State Council, strengthen the safety supervision of special equipment, and at the same time guide and facilitate the compliance declaration of enterprises.





Summary of emergency preventive measures in May

Vietnam

As Covid-19 nucleic acid was positive from 16 outer packaging samples of 12 batches of frozen Basha fish imported from Vietnam and 7 outer packaging samples of 7 batches of frozen South American white shrimp. According to the regulation of Announcement No.103 of General Administration of Customs in 2020, the national customs has suspended the acceptance of product import declarations from three aquatic products manufacturers in Vietnam (registration numbers are DL 717, DL 07 and DL 155 respectively) for four weeks since April 28th, and suspended the acceptance of product import declarations from two aquatic products manufacturers in Vietnam (registration numbers are DL 712 and DL 726 respectively) for five consecutive weeks.

Russia

As Covid-19 nucleic acid was positive in 11 outer packing samples of 2 batches of frozen Pacific herring, 5 batches of frozen narrow cod and 1 batch of frozen real cod directly imported from Russian fishing boats, which were stored in South Korea. According to the regulation of Announcement No.103 of General Administration of Customs in 2020, the national customs suspended the acceptance of the import declaration of products from a Korean company (registration number KP-695) from April 30th to June 3rd. The product import declaration of a Korean company (registration number KP-015) will be suspended from 4 weeks to July 24th, the product import declaration of a Russian fishing boat (registration number CH-62Q) will be suspended from 8 weeks to July 3rd, and the product import declaration of a Korean company (registration number KP-172) will be suspended from 8 weeks to September 26th.



Ecuador

As Covid-19 nucleic acid was positive in four outer packaging samples and two inner packaging samples of three batches of frozen South American white shrimp imported from Ecuador (both of which were declared before emergency preventive measures were taken continuously in the last time), according to the provisions of Announcement No.103 of General Administration of Customs in 2020, Since May 6th, the national customs has continued to suspend the acceptance of the product import declaration of Procesador a Posorja Proposorja S.A. (registration number 7453) and EXORBAN S.A (registration number 5658) from 4 weeks to July 26th, respectively. Import declaration of products of expodora total seafood S.A. (registration number 8503) will take 4 weeks to September 5, 2023.

Summary of emergency preventive measures in May

Russia

Four batches of frozen narrow cod, one batch of frozen salmon and one batch of frozen Pacific cod caught by Russian fishing boats and stored in South Korea, one batch of frozen black cod caught by Russian fishing boats and stored in the Netherlands, and one batch of frozen Arctic sweet shrimp directly imported from Russian fishing boats were found to be Covid-19 nucleic acid positive. According to the regulations of General Administration of Customs Announcement No.103 in 2020, Since May 8th, the national customs has suspended the product import declaration of a Russian fishing boat (registration number CH-281) for 5 weeks to June 11th, suspended the product import declaration of a Russian fishing boat (registration number CH-38N) and a cold storage in the Netherlands (registration number NL477EG) for 4 weeks to June 4th, and suspended the product import declaration of a Russian fishing boat (registration number CH-66Q) for 6 weeks. The import declaration of products from a Korean company (registration number KP-100) will be suspended for 13 weeks to August 6, and the import declaration of products from a Korean company (registration number KP-172) (declared before the last emergency preventive measures were taken) will be suspended for 4 weeks to October 24.

Ecuador

As Covid-19 nucleic acid was detected in five outer packaging samples of three batches of frozen South American white shrimp imported from Ecuador (two batches were declared before the last emergency preventive measures were taken), according to the regulation of Announcement No.103 of General Administration of Customs in 2020, the national customs continued to suspend the acceptance of the product import declaration of Pacfish S.A (registration number 6807), an aquatic product manufacturer in Ecuador, from May 8th to June 25th. The product import declaration of Negios Industriales Real Nirsa S.A. (registration number 51) will take 4 weeks to June 21st.

Pakistan

As Covid-19 nucleic acid was detected in two outer packaging samples of a batch of frozen sole imported from Pakistan, according to the regulations of General Administration of Customs Announcement No.103, 2020, the national customs suspended the acceptance of the product import declaration of M/s. Super Star Enterprises (registered number TEC-45/91) from May 10th to June 6th.

As Covid-19 nucleic acid was detected in two outer packaging samples of a batch of frozen South American white shrimp imported from Peru, according to the regulations of General Administration of Customs Announcement No.103, 2020, the national customs suspended the acceptance of the product import declaration of Peru's aquatic product manufacturer Corporacion Refri Gerados Iny S.A.C. (registered number P015-CRU-CRRF) from May 10th to June 6th.

Myanmar

As Covid-19 nucleic acid was detected in an outer package sample of a batch of frozen Penaeus monodon imported from Myanmar. According to the regulation of General Administration of Customs Announcement No.103, 2020, the national customs suspended the acceptance of product import declaration of Myint Myat Hein Co., Ltd (registered number YGN/090/MMH/DOF) from May 10th to June 6th.

Vietnam

As Covid-19 nucleic acid was detected in seven outer packaging samples of six batches of frozen barracuda imported from Vietnam, according to the regulations of No.103 of General Announcement Administration of Customs in 2020, the national customs suspended the acceptance of import declarations of products from three aquatic products manufacturers in Vietnam (registration numbers are DL 126, DL 367 and DL 801 respectively) for four weeks until June 15, 2022.
