RCEP Will Take Effect for Philippines on June 2

This signifies that the RCEP will take full effect for all 15 member countries and the world's largest free trade area will enter a new stage of full implementation.





In services and investment

The Philippines has committed to opening its markets to more than 100 service sectors, significantly opening up maritime and air services, and giving foreign investors more definitive access commitments in the areas of commerce, telecommunications, distribution, finance, agriculture and manufacturing.

Trade in Goods

After the RCEP comes into effect for the Philippines, in the field of trade in goods, based on the China-Asean Free Trade area, the Philippines has added zero-tariff treatment for Chinese automobiles and parts, some plastic products, textiles and garments, air conditioners and washing machines, and other products. After a certain transition period, the tariffs on these products will be gradually reduced from 3%-30% to zero.






New Progress in Mutual Recognition of AEO

Notice No. 49, 2023 of the General Administration of Customs shall come into effect on June 1, 2023. The Mainland and Macao Customs have reached mutual recognition of "Certified Business Operators" (AEOs)





China-Uzbekistan Customs

On May 18, at the China-Central Asia Summit, the "Arrangement for Mutual Recognition of the Certified Operators" System was signed.

New Progress in Mutual Recognition of AEO




AEO--

"Authorized Economic Operator"

The AEO system, initiated by the World Customs Organization, aims to facilitate customs clearance by certifying enterprises with high law-abiding degree, credit status and safety level.

Specific facilitation measures for customs clearance

- ü Low documentation review rate is applicable;
- ü Low inspection rate is applicable;
- ü Give priority to goods requiring physical inspection;
- ü Designated customs liaison officer, responsible for communicating and dealing with problems encountered by √AEO enterprises in customs clearance;
- ü Priority should be given to customs clearance after international trade is interrupted and resumed .



Advantages of AEO certification in international trade

- ü Efficient and uniform supply chain standards and procedures
- ü Reduce inspection rate
- Reduce document review and other requirements
- ü Provide valuable information to AEO participants
- ü Special measures during periods of trade disruption or enhanced trade security

National Layout of AEO Mutual Recognition

They include 35 countries along the Belt and Road, 5 RCEP members and 13 Central and Eastern European countries. The import and export volume of Chinese AEO enterprises to AEO mutual recognition countries or regions accounts for 60% of their total import and export volume.





Lithium-ion Batteries and Other Products Will Be Included in the 3C Certification in 2024



Since August 1, 2023, the designated certification body began to accept the CCC certification of newly included products, in accordance with the "Mandatory Product Certification Implementation Rules Information Technology Equipment" and the applicable standards listed in the annex to carry out certification work;

At present, the portable electronic products for lithium-ion batteries and battery packs to be carried out CCC certification; For lithium-ion batteries and battery packs used in other electronic and electrical products, CCC certification will be carried out when conditions are mature.



Since August 1, 2024, those without the CCC certification certificate and the certification mark shall not be allowed to leave the factory, sell, import or use in other business activities.



After a comprehensive assessment of the rectification measures taken by the Australian side and in accordance with relevant Chinese laws and regulations and international standards, it is now decided to resume the import of Australian logs from May 18, 2023.

The General Administration of Customs has decided to pilot in the Shanghai Customs the reform of integrating the Import Certificate of Goods (Automobiles and Motorcycles) and the Inspection List of Imported Motor Vehicles.

China Customs will launch new Plant Quarantine Certificate in June

China Customs will launch new Plant Quarantine Certificate and new Entry and Exit Inspection and Quarantine Plant Transshipment Quarantine Certificate on June 1,2023.

Adjustment of the list of narcotic and psychotropic drugs

Oxelidine will be included in the list of narcotic drugs; suvoresan, pirampanel, etazocine and Tramadol compound preparations will be included in the Category II list of psychotropic drugs from 1 July 2023.









Anti-Dumping

With effect from 10 May 2023, anti-dumping duties on imports of chloroprene rubber from Japan, the United States and the European Union will continue to be imposed with a period of 5 years, the duty rate rangeing from 10.2% to 151%. The HS code of the product 40024910 or 40024990. 。

Almond Seed

From 20 April 2023, qualified Spanish almond imports will be allowed. Almond seeds that are allowed to be exported to China refer to nuts with skin on or peeled for human consumption made from Prunus dulcis (Mill.) D.A.W., the fruit of almond planted in Spain, through processing techniques such as hulling, drying and selection in Spain.



Dairy Products

From April 16, 2023, feed dairy products from France that meet the relevant requirements will be allowed to import. Feed dairy products permitted to be exported to China refer to feed dairy products made from raw milk or by-products (whey, buttermilk, buttermilk, colostrum, etc.) that contain vegetable ingredients, vitamin premixed feed, probiotics and other raw and auxiliary ingredients approved for use by Chinese and French laws, and feed dairy products made from raw milk or auxiliary products that do not contain the above raw and auxiliary ingredients.

Brazilian terrestrial animal protein feed

Imports of Brazilian terrestrial animal protein feed that meet the requirements will be allowed from May 4, 2023. Terrestrial animal protein feeds permitted to be exported to China refer to avian protein feeds and pig protein feeds, including meat meal, bone meal, meat and bone meal, blood meal and feather meal.











Dushan Port / Geographical Location Map












