### Preface:

China is a large country in the production and export of lithium battery products, and the export volume continues to increase significantly. However, lithium batteries are dangerous goods, and accidents such as fire and explosion may occur during transportation, and their transportation safety must be paid attention to.



### 1 Key Points of Standard Declaration for Export Lithium Battery







### **Commodity Inspection**


At present, the HS code of lithium battery related products has no inspection and supervision conditions, and there is no need to implement import and export commodity inspection.

### Appraisal for use

However, lithium batteries are dangerous goods, and manufacturers of export lithium battery products shall apply to the Customs for identification of the use of dangerous goods packaging containers.(According to Article 17 of Law of the People's Repuvlic of China on Import and Export Commodity Inspection)

### **Key points for Declaration**

UN number for Lithium battery is 3090, 3091, 3480, 3481, the "cargo attributes" should be selected 19 normal and 33 nonhazardous chemicals, non-hazardous goods should be select "No". the correct UN number, dangerous category, packaging category, packaging UN mark should be filled in.



Relevant international danger regulations are the International Maritime Dangerous Goods Code (IMDG), the International Carriage of Dangerous Goods by Rail Code, the International Agreement on the Carriage of Dangerous Goods by Road (ADR), the Dangerous Goods Code (IATA-DGR), the United Nations Manual of Tests and Standards for Model Regulations for Recommendations on the Transport of Dangerous Goods.



### 1 Special Subject on Standard Declaration of Lithium Battery





Definition: Lithium-ion batteries generally use lithium metal oxide or lithium alloy oxide as a positive electrode material, graphite as a negative electrode material, and the use of nonaqueous electrolyte batteries.


Definition: Lithium batteries with lithium metal or lithium alloy as the anode are usually non-rechargeable disposable batteries.












# 1 Key Points of Customs Physical Examination for Export of Lithium Battery Products







### Packaging Specifications



### Requirements for Products

Unless exemption conditions are met, exported lithium batteries must pass the UN38.3 test and provide a summary of the test. Each cell and battery pack should have a safety exhaust device, which should be designed to prevent force damage in the event of a common accident.

#### **Identification Label**

The package must be marked with the lithium battery type 9A Dangerous Goods Label for lithium batteries or lithium battery packs in accordance with Article 188 using the "Lithium battery type specific marking" if posted outside the cargo transport unit, the type 9 dangerous goods label will still be used.

## 1 New Regulations on Lithium ion Battery CCC Mandatory Certification




### August 1, 2023

The designated certification body began to accept the CCC certification of the newly included products, and carried out the certification work in accordance with the applicable standards listed in the "Mandatory Product Certification Implementation Rules Information Technology Equipment" and the annex.

### Implementation Rules of the New Standard for Lithium-ion Batteries

GB 31241-2022 《The Safety Technical Specification for Lithium-ion Batteries and Battery Packs for Portable electronic Products will be implemented from January 1, 2024, and it will replace GB 31241-2014. The old standard certificate will no longer be issued.



### August 1, 2024

The three products, including lithium-ion batteries, which have not obtained the CCC certification certificate and marked with the certification mark, shall not be manufactured, sold, imported or used in other business activities.

#### **Transitional Measure**

From March 1, 2023 to December 31, 2023, enterprises can voluntarily choose to implement certification in accordance with the new standard or the old standard.


## Innovation one: The Third Party Test Report of Garments Accepted by Customs as the Basis for Conformity Assessment







### Benefit for Enterprises: Imported Garments Exempt from Sampling



#### **Attribute of Goods**

When declaring in the single window of China International trade, independently choose whether it belongs to the scope of accepted goods, select the scope of accepted goods in the "goods attribute" column of the customs declaration page and check the type of "46- Inspection results accepted".

#### **Attached Documents**

"Declaration of Quality and Safety Conformity and list of goods and corresponding inspection report list" in the attached document column should be uploaded.



## Innovation two: High-Tech Measure Such As Vacuum Packaging Renovating Inspection and Control Mode



Benefit for Enterprises: The registered goods of registered enterprises shall be exempted from unpacking inspection at the port of import and shall be transferred to the destination for inspection

"Ten measures to promote foreign trade by ensuring stability and improving quality". The Article 1 is: Do a good job in integrating layout control inspection mode expansion pilot work for vacuum packaging and other high-tech goods.

### Substantial Benefits for Enterprises

Import: The registered goods of registered enterprises, in addition to the inspection instructions that must be executed at the port, are exempted from the unpacking inspection at the port when imported and transferred to the destination for unpacking under the supervision of the Customs to further reduce the risk of material damage to high-tech goods.



### Scope of Goods

Vacuum packaging, anti-light packaging, dust-proof packaging, constant temperature storage and other high-tech products that are not suitable for unpacking and inspection in the ordinary environment, and expand the scope of goods to the same batch of importation and declaration of high-tech goods.

### **Enterprise Application Process**

The application of the enterprise -- the initial examination of the registration Customs (the record information added or adjusted in the previous month should be submitted to the risk control branch before the 5th of each month) -- the risk assessment record of the regional customs.



# Innovation three: Shanghai Exempt from Mandatory Product Certification



Benefit for Enterprises: The relevant enterprises can use the CCC free convenient channel to enjoy the convenience of voluntary declaration, self-commitment and self-service.

### **Exemption Route**

Producers, importers, sellers or their agents whose products are included in the mandatory product certification catalogue issued by the State Administration of Market Supervision and Administration can apply to the District market Supervision Bureau for CCC exemption through the "CCC exemption and special purpose Import Product testing and processing management System"

02

### Requirements for Applicants

The applicant meets the conditions of good credit history, complete traceability system, and frequent CCC exemption business.

03

### Policies to Support Key Industries

For R & D and manufacturing enterprises in key industries such as integrated circuits, artificial intelligence, biomedicine, and aerospace, we provide CCC exemption rapid processing services and support them to become CCC exemption convenient channel users.

04

### Validity

These provisions shall come into force on July 1, 2023 and be valid until June 30, 2026.

## Five types of organic pollutants strictly limited

As of 6 June 2023, provisions have been made for the phase-out or restriction of 5 persistent organic pollutants, including hexachlorobutadiene, polychloronaphthalene, pentachlorophenol and its salts and esters, decabromodiphenyl ether and short-chain chlorinated paraffins

### Cherimoya

According to General Administration of China Customs, import of Cherimoyas from Taiwan are prohibited from September 20, 2021. Through comprehensive assessment of rectification measures of Taiwan Orchardists, GACC announced to resume import of Cherimoyas from Taiwan from June 20, 2023. Cherimoya imported to the mainland must come from registered packaging factories and orchards, and the list of relevant enterprises has been published on the website of the General Administration of China Customs.



#### **List of Prohibited Goods**

Environment and the General Administration of Customs put out the Announcement, No. 21 of 2023 (Announcement on the publication of the Catalogue of Prohibited Import Goods (Eighth batch) and the Catalogue of Prohibited Export Goods (Seventh batch)) Since June 6, 2023, the import of 9 prohibited products and export of 6 products are added. For laboratory-scale research or as a reference standard, the import and export prohibition is not applicable.

### **Anti-Dumping**

Ministry of Commerce: Initiated a final review investigation of the anti-dumping measures applied to imports of m-phenoxybenzaldehyde originating in India.



### 3 Early Warning of Enterprise Risk Information





Notice of the Ministry of Agriculture and Rural Affairs of the General Administration of Customs No. 72 of 2023 (Notice on lifting the ban on the outbreak of swine blister disease in other regions of Italy) The notice is as follows, on June 15, 2023, lifting the Italian swine blister disease epidemic area and banning the import of pigs and their products from the country.



### Belgium

Notice of the Ministry of Agriculture and Rural Affairs of the General Administration of Customs No. 71 of 2023 (on lifting the ban on boning beef under 30 months of age in Belgium), the notice is as follows, from June 15, 2023 the ban on imports of boning beef under 30 months of age in Belgium is lifited.



#### Poland

Notice of the Ministry of Agriculture and Rural Affairs of the General Administration of Customs No. 70 of 2023 (on lifting the ban on boning beef from Poland under 30 months of age), the notice reads as follows, the ban on imports of boning beef from Poland under 30 months of age is lifted from June 15, 2023.



#### Honduras

General Administration of Customs Announcement No. 68 of 2023 (Announcement on Phytosanitary requirements for the import of fresh bananas from Honduras) from June 13, 2023 the import of fresh bananas from Honduras that meet the requirements is allowed.






